#### 1. Call to Order

Chair Dyer called the meeting to order at 1:00 p.m. Chair Dyer asked Commissioner Janer to lead the Pledge of Allegiance.

#### 2. Approval of Minutes

Commissioner Janer moved to approve the Board of Directors meeting minutes of October 28, 2021. Commissioner Constantine seconded. The minutes were unanimously approved as presented.

#### **3.** Public Comments

Tom Egan – Orlando, FL Mr. Egan gave an update on MV Transportation.

Anne Lott – Orlando, FL Ms. Lott requested more frequent service in her area.

#### 4. Chief Executive Officer's Report

Jim Harrison, Chief Executive Officer, stated that he attended the American Public Transportation Association (APTA) conference. LYNX staff was very involved with coordination efforts. The next APTA conference will be back in Orlando in 2023.

LYNX staff participated in FDOT's Mobility week by waiving fare collection on October 29. LYNX supported Try Transit Tuesday, and partnered with MetroPlan Orlando for the Blind Experience at Orlando City Hall

The FastLink Zero Demonstration was very informative and very successful. This was a technical demonstration and showed the range of the electric buses and allowed LYNX to partner with Orange County, City of Orlando, CFX, GOAA, OUC and private vendors like ABC Companies and Proterra.

Ridership continues to remain steady, and next week will begin the new service changes.

LYNX hosted Congresswoman Val Demings as she announced the opportunity for this region with the passage of the Infrastructure Investment and Jobs Act Bill. LYNX staff is identifying the projects that will fit in with the guidance of this bill.

There are two items on today's agenda that were pointed out: Contract extension with Vector Media for the Advertising program, and the purchase of twenty-five Compressed Natural Gas (CNG) buses.

The annual tradition of Santa driving the bus started on December 1 and will run through December 24.

#### 5. Oversight Committee Report

Commissioner Janer, Chair of the Oversight Committee provided her report on the Oversight Committee meeting that met earlier. She stated that the committee approved the minutes from the October 28, 2021, Oversight meeting.

#### **ACTION REQUESTED:**

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to issue an Invitation for Bid (IFB) for the repainting of existing bus shelters. This painting is part of a larger effort for shelter rehabilitation.

#### **BACKGROUND:**

LYNX currently has approximately 4,500 bus stops within its 2,500-mile service area. One of the most requested improvements to a bus stop from passengers is the addition of a bus shelter. After this, the next most requested improvement is the repainting of existing bus shelters. Currently, LYNX repaints shelters approximately every 10 years. Since starting the repaint program in 2017, LYNX has successfully repainted approximately 105 shelters. For 2021/2022, LYNX is currently in the process of repainting another 100 shelters throughout the service area. The purpose of this request is to solicit bids specifically for the repainting of all style of LYNX bus shelters. LYNX has been continuously coordinating with local funding partners for appropriate color schemes.

Currently, existing contracts are in place to replace items on shelters needing updating such as the seating and roof panels. This IFB would allow for the in-situ painting of the bus shelters. By painting in-situ, LYNX is able to save approximately 30 percent off of the cost of an entirely new shelter. In addition, by combining the replacement of parts (i.e. roof panels and seats) with the repainting, LYNX is able to leverage and maximize capital funding from the Federal Transit Administration instead of operating funding.

#### **DISADVANTAGE BUSINESS ENTERPRISE (DBE) PARTICIPATION:**

#### **ACTION REQUESTED:**

#### **BACKGROUND:**

With LYNX Board Approval on July 22, 2021 under Consent Agenda Item #6.B.ii, a contract was awarded to Klen Space, Inc. for the bus and facility disinfecting services. The contract award was made with the understanding that the scope of the disinfecting services were contingent to the installation of a vehicle disinfecting system on the LYNX fixed-route and paratransit fleets. Prior to the execution of the contract with Klen Space, Inc., the vehicle disinfecting systems were installed on the LYNX fleets. Klen Space, Inc. was unwilling to move forward with the contract after the reduction in scope based on the removal of the vehicle disinfecting portion of the services.

LYNX approached the next firm on RFP #21-R27 for Facilities and Bus Disinfecting Services, Jani-King of Orlando, LLC and they agreed to the reduced scope of services.

The RFP was released on August 20, 2021, and proposals were due September 20, 2021, at 4:00 pm. A single proposal was received and the SEC met on November 11, 2021 to evaluate and score proposals.

#### **ACTION REQUESTED:**

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to amend the contract for the processing service rates with Ceridian for Human Resource and payroll processing.

#### **BACKGROUND:**

At the May 24, 2018 Board Meeting, the LYNX Board of Directors approved to renew the contract with Ceridian. This contract renewal consisted of upgrading our existing software package with Ceridian to a cloud-based version that would be more cost effective, provide better information and provide for continuity of service during emergency situations.

The current contract includes two separate rates for usage: \$10.75 per person for the payroll system only and \$12.25 per person for the full workforce management system functionality. Ceridian has proposed to establish a single rate of \$11.06 so that all LYNX employees can utilize the full functionality of the system. There is no change to the annual cost of the system or terms of the original agreement.

#### **ACTION REQUESTED:**

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to execute a change order with R.L. Burns, Inc. for the construction of safety, security, and aesthetic improvements to the Rosemont Transfer Center in the amount of \$28,299.74.

#### **BACKGROUND:**

In August 2020, the LYNX Board of Directors authorized the Chief Executive Officer or designee to execute Contract #20-C69 with R.L. Burns, Inc. for the construction of safety, security, and aesthetic improvements at the Rosemont Transfer Center in the amount of \$612,564.55.

At the March 2021, Board of Directors meeting an increase to the contract amount as a result of contract negotiations was approved in the amount of \$16,552.95.

The total revised project cost is \$629,117.50. This included a contingency amount of \$57,192.50. All of the change orders are within the project contingency.

As per Administrative Rule 4.5.4, LYNX staff can authorize change orders up to 50 percent of the project contingency. The change orders processed to date related to this are as follows:

- Maintenance of Traffic: \$9,175.32-This change order was for added maintenance of traffic for the project required due to delays once the permit was issued. The City of Orlando required extra information post permitting and the utility locates took approximately 3 weeks to perform their work. The contractor was granted 3 extra weeks of time as a result.
- Security: \$10,736.00-Due to extreme vandalism at the site, the contractor was granted a change order for the use of security services to protect both equipment and finished work product.
- **Directional Bore**: \$6,115.20-During permitting, LYNX proposed that any installation of conduit would be through an open cut. Post permitting, LYNX was informed that any installation of conduit under the drip line of the tree could not be open cut and would have to be a directional bore. This covers the direction bore under the roots of two trees.
- **Stump grinding**: \$480.00 The city identified that one of the many trees on site was off poor quality and was able to remove it at no charge to the project. The resulting stump was required to be ground down to 4 inches below grade.

In addition, as per Administrative Rule 4.5.4, LYNX staff requires Board of Directors approval for any change order greater than the 50 percent contingency These change orders are as follows:

- **Type Sixty-Seven (67) Stone Removal**: \$6,480-During permitting, LYNX proposed under the bus lane being constructed to install 4 inches of asphalt and 4 inches of Type 67 stone. Post permitting, LYNX was informed that the City would only accept 8 inches of crushed concrete. This change order is to address that change. The crushed stone will actually be able to be used on another project.
- **OUC and bus shelter fixtures**: \$17,679.83-It was assumed as part of the OUC and shelter related lighting costs that the fixtures were included. As these fixtures are an upgrade from the standard, these were not factored into the original bid. This cost will allow for the purchase of those fixtures.
- **Concrete and Landscaping:** \$4,139.91-During construction, a manhole for stormwater was discovered buried under 2 feet of grass. In addition, a driveway associated with a utility easement needed to be adjusted to ensure a proper access slope to meet the American with Disability Act. Further, the area in which the previously mentioned tree was removed was determined to need landscaping to address the void left by its removal.

The table below details the change orders that have occurred as part of the project. The balance left in contingency is \$2,386.24. Only those change orders above the 50 percent contingency mark require the approval of the LYNX Board of Directors and have been highlighted in grey.

#### **ACTION REQUESTED:**

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to purchase eight (8) 2022 Ford Utility AWD V-6 replacement automobiles for a not-to-exceed amount of \$400,000.00. These replacement automobiles will be purchased through the Florida Department of Management Services, Motor Vehicles State Purchase Contract 25100000-21-STC.

#### **BACKGROUND:**

Lynx has an active support fleet of 115 vehicles; these eight (8) automobiles are replacements for transportation vehicles that have met their useful; of either five (5) years or 100,000 miles. #### **ACTION REQUESTED:**

Staff is requesting the Board of Directors' authorization for the Chief Executive Officer (CEO) or designee to increase the not to exceed amount for Contract #22-C11 with Jobbers Equipment Warehouse, Inc., for Rotary Mod30 Telescoping Hydraulic Cylinder Replacement to the amount of \$335,000.

#### **BACKGROUND:**

On September 23, 2021, staff received authorization to award Contract #21-C11 to Jobbers Equipment Warehouse, Inc., for Rotary Mod30 Telescoping Hydraulic Cylinder Replacement to the amount of \$315,119.41. Upon negotiation of the contract terms, Jobbers Equipment Warehouse, Inc., informed LYNX that due to the increases in steel and freight costs they would not be able to meet the costs they proposed in the RFP. They requested a cost adjustment of \$19,880.59 in order to move forward with the contract. LYNX performed an analysis of the costs proposed by other respondents to the RFP and found that the requested price increase was still well below the quote of the next lowest bidder.

The purpose of this project is to replace all the cylinders with new upgraded cylinders from the OEM or an authorized supplier of OEM parts. The new cylinders will have the protection of a warranty and readily available replacement parts. Performing the replacement of the lift cylinders (posts) will increase the reliability of the lifts and decrease lift downtime related to cylinder failures. This will result in decreased operating costs related to facility repairs, increased shop productivity and reduced revenue fleet vehicle downtime.

## **DISADVANTAGE BUSINESS ENTERPRISE (DBE) PARTICIPATION:**

No DBE Goal has been established for this contract. LYNX encourages the Contractor to make every attempt to obtain participation of certified DBEs and other small businesses in the completion of this contract (Race Neutral).

SUBJECT: ServiceEdge Solutions, Inc. -TBEST (Transit Boarding Estimation and Validation Tool) – Annual Support Services

**BACKGROUND:** LYNX implemented the TBEST software into the planning processes in FY 2010 to support the major Transportation Development Plan (TDP) update. The utilization of this software in the TDP update is a requirement by the Florida Department of Transportation (FDOT) for all Florida transit agencies. With this software implementation LYNX received tools to support regular updates to the transit system in the model, by utilizing the GTFS data exports. Since 2010, LYNX utilized outputs of this modeling software for other planning tasks such as the federally required Title VI evaluation reporting of the impact of proposed service and fare changes, which is undertaken each time there are changes in services and fares.

Currently LYNX is using TBEST to develop socio-economic data for evaluation of current services and to inform predictions on the potential ridership impacts of proposed changes in the LYNX transit system. TBEST data analysis is also leveraged as part of Transit-Oriented Development analysis around existing LYNX Super Stops. Analysis completed with the TBEST tool is a key requirement for completing LYNX's Transit Development Plan (TDP) Major Update in FY 2022.

#### SOLE SOURCE JUSTIFICATION:

ServiceEdge Solutions personnel developed the T-BEST software in 2003, and has been granted permission by FDOT to modify the software for use in the public domain. No other vendors have been granted permission by FDOT to modify the TBEST software. ServiceEdge solutions is the authorized firm and has unique knowledge of the TBEST data model and can extend the model or write custom scripts to support additional TBEST data processing required by LYNX. Because ServiceEdge Solutions has calibrated TBEST models in Florida and in Los Angeles; implemented the tool for agencies in Utah, Tennessee, Georgia, Oregon, and Texas, ServiceEdge brings national experience for model application and calibration. No other vendors have calibrated TBEST models for this many major metropolitan areas.

#### **COST/PRICE ANALYSIS:**

The cost for support for October 1, 2021 – September 30, 2022 will not exceed \$50,000 and will be based on billing provided for support hours related to the aforementioned state and federal requirements.

The latest SEON management and viewing software is backwards compatible with all existing equipment currently deployed by LYNX and can also be used with all proposed equipment. Procurement of similar equipment from another manufacturer would require duplicating the infrastructure with that manufacturer's solution for viewing, wirelessly downloading, organizing, and storing video files. The expense of duplicating these capabilities would be costly for existing assets already owned by LYNX.

"This is a huge win for Florida, and I am excited about all that we are going to accomplish in the coming years because of this investment in our future." But her husband, Orange County Mayor Jerry Demings, cautioned that the one- time influx of cash won't be enough to provide the continuous funding source the county needs. He said he would continue to push for a one-penny sales tax increase on the ballot next year for Lynx and other transportation needs.         The \$19 billion for Florida includes an estimated \$1.2 billion in improvements for airports, \$13.1 billion in federal aid for highways, \$245 million for bridge replacement and repairs, \$198 million toward expanding the state's electric vehicle charging network, and \$2.6 billion for public transportation. The expansion of the Lynx system, Rep. Demings said, was a necessary step in an area going through a population boom.

	Among the beneficiaries of a convention center train station, these <u>tourist</u> <u>businesses say</u> , are commuters who work on the International Drive corridor. Color us skeptical that Brightline — a high-speed system starting in Miami — is designed or priced to help low-paid restaurant and hotel workers get to and from their jobs every day.

	All the more reason for these hotel and theme park executives to back a bill, introduced by Orlando Democratic state Rep. Anna Eskamani, that would finally allow counties that charge a tax on lodging to spend some of the proceeds on services that residents, including workers, need. Services like buses, rail, sidewalks and storm drainage.
	Eskamani's proposed measure — <u>House Bill 6075</u> — is a test of tourism's sincerity about wanting to help their workers. It's also a test of state lawmakers who say they support working-class Floridians, but then rig the economy against them at every turn.
	With Eskamani's bill, they have an opportunity to finally help those workers by giving counties like Orange more say and more options on how to spend a portion of the annual bounty collected from tourists who stay overnight.

- and that's not even close to pre-pandemic totals. Coincidentally, \$176 million is almost exactly how much it costs to run the tricounty bus system known as Lynx for a full year. Just imagine if a sliver of the tourist tax money could be used to help Lynx run more buses more often to move hospitality workers between work and home, and tourists from hotels to attractions and restaurants. By state law, however, that money can only be spent on ads and marketing and convention centers, all designed to attract even more visitors. The money also is eligible to bankroll arenas and stadiums, which is a nice perk for residents who are able to afford tickets to basketball and football games. Not so nice for service workers living paycheck to paycheck. The law's been loosened up in other parts of the state in recent years. Leaders in Brevard County advocated to spend tourist tax money on cleaning up the Indian River Lagoon, and several Panhandle counties won the ability to spend it on lifeguards. Great. Now the state needs to keep uncuffing counties by giving more local elected officials greater control over how the money they collect gets spent. Eskamani's bill has plenty of checks and balances to ensure counties don't go rogue and spend the money foolishly.

The amount of money at stake is staggering. Orange County collected \$16.5 million in September alone, finishing the 2020-21 fiscal year with \$176.9 million

Any spending on public facilities has to provide some benefit to tourism. Plus, the existing advisory boards that include tourism representatives will remain involved. And county commissioners have to approve spending by a two-thirds vote, which means five of Orange County's seven commissioners have to vote yes. That's a high bar.

Florida needs to end the monopoly tourism has over a tax that was enacted some 40 years ago. Since then the tax has gone from 2% to 6% and hundreds of millions of public dollars have been spent on the convention center, arenas, and more TV ads than you could possibly count.

It's long past time to start doing more to improve the lives of the tens of thousands of people who keep tourism functioning.

To our mind, Eskamani's bill doesn't go far enough. Ideally it should allow counties to spend money on better schools and police protection. Las Vegas has had a more enlightened policy on how to spend its tourist tax money for years. We suspect Eskamani is probably trying to enact a change that won't generate too much resistance from tourism interests. Fair enough.

Which brings us back to the captains of industry from Universal, SeaWorld and
International Drive, who say one of the reasons they want to force Brightline to
move its proposed route to include the convention center — before stopping at
Disney World — is so workers can get around better.
Splendid. We agree completely that workers need a break. But let's be honest
here — how many workers are going to benefit from a fast train that connects
Orlando International Airport with the convention center? Not many. Workers are
far more likely to be helped by bus routes that don't force them to spend hours of
their day waiting or riding, time they could spend at home with family.
If the I-Drive merchants who are agitating for a Brightline stop don't also support
Eskamani's bill, we'll know what this is really about: Just getting more tourists to
spend money at their theme parks and hotels.

And if the Republican-controlled Legislature doesn't pass this bill, that's just
more evidence their claims of working class advocacy are just shtick. This is a
Legislature with a record of opposing higher minimum wages and paid sick while
robbing a state fund intended to create more affordable housing.
Instead, in the best tradition of Marie Antoinette public policy, they create brief,
gimmicky sales tax holidays that amount to financial crumbs with no lasting
benefit.
The time has come for Florida to do some lasting good for its service workers,
like providing them with a bus system that works. Eskamani's bill is a start.

The attached monthly Performance Report includes September Year-To-Date figures for ridership and other performance indicators. Total ridership for October 2021 was 1,345,393. This is a 16.5% increase from October 2020. On-Time Performance for Fiscal Year-To-Date 2022 is 75%.

- LYNX overall ridership increased by 190K, or 16.5%, compared to October 2020. Year-to-date ridership for FY-22 (1,345,393) increased 16.5% compared to FY-21 (1,154,811)
- LYMMO ridership decreased by 7K, or 17%, compared to October 2020. Year-to-date ridership for FY-22 (35,194) decreased 17% compared to FY-21 (42,383).
- Fixed Route ridership increased by 198K, or 19.1%, compared to October 2020. Year-todate ridership for FY-22 (1,240,405) increased by 19.1% compared to FY-21 (1,041,411).

LYNX ridership increased by 190K, or 16.5%, compared to October 2020. System-wide average weekday riders increased by 19.0% year-to-date.

*LYMMO* ridership decreased by 7K, or 17.0%, compared to October 2020. Average weekday ridership for LYMMO was down 12.6% in October 2021.

*Fixed Route* ridership increased by 198K, or 19.1%, compared to October 2020. Average daily ridership increased by 21.1% compared to the same time period last year. The COVID-19 pandemic was responsible for the decreases in ridership during the last year.

*NeighborLink* ridership decreased by about 400, or 6.5%, compared to October 2020. The overall reduction for the year was primarily due to the COVID-19 pandemic.

ACCESS LYNX ridership increased by about 1K, or 5.4%, compared to October 2020. COVID-19 had caused a decrease in ridership during the year.


Vanpool ridership decreased by about 3K, or 12.3%, compared to October 2020. COVID-19 had cause a decrease in total Vanpool utilization.




## MONTHLY RIDERSHIP TRENDS BY MODE




LYNX ridership increased by 16.5% compared to the same time last year. Average weekday riders increased by 19.0%.




Fixed route ridership increased 19.1% compared to October 2020. Average weekday riders increased by 21.1%.




ACCESS LYNX ridership increased by 5.4% compared to October 2020. Average daily riders were up by 9.3%

# **Definitions of Metrics Used on the Monthly Performance Data Sheets**

**Ridership** – The number of trips taken by people using a public transportation system in a given time period.

Passengers per Trip – The average number of passengers who ride on a revenue trip.

**On-Time Performance** – Refers to the level of success of the service operating according to the published schedule (LYNX defines a bus as on-time if it falls within 0 minutes early to five (5) minutes late of the published schedule).

Farebox Recovery – The percent of a trip's operating costs recovered through passenger fares.

**National Transit Database (NTD) Reportable Accidents** – A safety or security event occurring on transit right-of-way or infrastructure, at a transit revenue facility, at a transit maintenance facility or rail yard, during a transit related maintenance activity or involving a transit revenue vehicle that results in one or more of the following conditions:

- A fatality confirmed within 30 days of the event
- An injury requiring immediate medical attention away from the scene for one or more person
- Property damage equal to or exceeding \$25,000
- Collisions involving transit revenue vehicles that require towing away from the scene for a transit roadway vehicle or
   other non-transit roadway vehicle
- An evacuation for life safety reasons

Complaints per 100,000 Miles – Total number of complaints received based off of every 100,000 vehicle miles.

Total Trips Scheduled – Number of vehicle revenue trips scheduled to operate for the month.

**Percentage of Scheduled Trips Operated** – Percentage of the total of the revenue trips that were actually operated for the month compared to the number that were scheduled to operate.

Fleet Availability – Shows the extent to which the bus vehicle fleet is available for revenue-earning work.

**Preventative Maintenance Completed On Time** – Percentage of the total number of scheduled preventive maintenance inspections that were completed on time.

Collected Fares - Percentage of fares collected from passengers to use the service.
