

APENDIX A SCOPE OF WORK AND TECHNICAL SPECIFICATIONS

Parking Lot - Seal Coat and Striping

Background

The Central Florida Regional Transportation Authority ("LYNX" or the "Authority") is an agency of the State of Florida, created by the Florida Legislature to own, operate, maintain, and manage a public transportation system in the area of Orange, Osceola, and Seminole Counties. The Authority's enabling legislation (Florida Statutes Section 343.64) has the express intention "that the authority be authorized to plan, develop, own, purchase, lease, or otherwise acquire, demolish, relocate, equip, repair, maintain, operate, and manage a regional public transportation system and public transportation facilities; to establish and determine such policies as may be necessary for the best interest of the operation and promotion of a public transportation system; and to adopt such rules as may be necessary to govern the operation of a public transportation system and public transportation facilities." In 1993, the Authority began doing business as "LYNX".

Project Overview

LYNX is interested in securing a contractor for cleaning and sealcoating the existing LYNX Operation Center (LOC) asphalt parking lot. Once the sealer dries, stripe the parking lot lines in white reflective traffic paint to match existing stalls.

Contractor shall provide all labor, tools, materials, equipment, supplies, transportation, including travel, and every other item of expense necessary to provide Parking Lot Seal and Stripe, in accordance with this Scope of Work (SOW).

Minimum Qualification:


- 1. Contractor must submit a copy of their license to do Business in the State of Florida. Contractor, at Contractor's own expense, shall maintain and possess such license, and any and all necessary license(s), permit(s), and certificate(s) required by law throughout the entire term of the contract. Such license(s) permits(s), and certificate(s) shall be in full force and effect prior to conducting any work required in connection with this contract.
- 2. Contractor must submit proof of insurance.

Summary of Work

Contractor shall apply two (2) coats of asphalt seal covering on all asphalt surfaces after having completed all asphalt surface preparation as indicated on the specifications or indicated at the site visit. Work includes replacement and reinstallation of plastic wheel stops with concrete ones and washing, cleaning and reinstallation of existing concrete stops. Re-stripe all spaces and lines

Important Notes:

1. **Specified Amount:** Contractor is responsible to inspect and evaluate the condition of the site prior to responding with a Quote.





- 2. <u>Discrepancies:</u> Contractor shall immediately contact LYNX for further instructions before proceeding should there arise any error, discrepancy, or doubt as to the intent and purpose of the layout and specifications.
- 3. **Layout Change:** All items relating to colors, textures, finishes, or otherwise pertaining to the current appearance shall not be changed without prior approval from LYNX.
- 4. All works must be done on weekends.

Specifications:

Seal coat must be a coal tar emulsion and meet or exceed requirements for Federal Spec R-P-355e, ASTM D 5727 & FAA P-625, P-627, P-630, and P-631.

Asphalt surface must be cleaned up prior to seal coat, which includes removal of oil or grease spots by scrubbing with a detergent and flushing with water, as well as removal of all loose surface debris such as dirt, dust, and leaves by sweeping, blowing, flushing with water, or a combination of the three.

- ❖ Mix design shall be as follows, with a minimum of 4 hours between coats: Coat #1 − 100 gallon concentrate/30-35 gallon water/3 pound sand/3 gallon latex additive Coat #2 − 100 gallon concentrate/30-35 gallon water/3 pound sand/3 gallon latex additive
- Striping to be done with a latex or acrylic paint approved by the manufacturer for use in parking lot striping, federal spec TT-P-1952B or above. No reduction allowed. No striping is to be done until seat coat has cured for a minimum of 24 hours. Application thickness will be 15mil, provided in 2 coats. Traffic control markings will be a minimum of 24 inches, handicap symbols will be a minimum of 60 inches. Stripe to be white.

Parking Lot Estimated Quantities:

- A. **89,000** Approximate Parking Lot Sq. Ft. Asphalt Seal Coating (AS)
- B. AS IS Lin. Ft. Line Striping or as existing
- C. **16** Number of Handicap Parking Stalls
- D. All Number of oil spots to be ground
- E. **6** Plastic stops to be replaced with concrete stops
- F. **8** Motorcycle parking that will also need to be re-marked after Sealcoat.
- G. **8** Existing concrete stops to be cleaned up before reinstallation

Contractor shall refer to above estimation for dimensions and quantities. All dimensions are approximate. It is the Contractor's responsibility to verify all quantities and submit it as part of Quote.

Warranty:

All supplies and materials supplied by the contractor shall be new. The contractor shall warrant that workmanship and furnished and installed materials that are free from defects for at least one (1) year. Furthermore, the contractor shall replace or repair any part that has failed under normal operation within that warranty period at NO additional cost to LYNX. A written sample warranty must be included with the Quote.
